### **Filing Tax Returns Online**

Free File sites are for those who meet certain requirements to file taxes online for free. \*\* *Some sites charge for the service but waive the charge if the person goes to their site via the IRS website.*

Each site has a different set of requirements. *All free filers must make less than 58,000 per year.* Patrons will need to make their own choice on which service they use.
